SUBJECT:	NOTICE OF APPEAL TO THE ONTARIO MUNICIPAL BOARD CITY OF LONDON BY-LAW: L.S.P. 3431-177 BLACKFRIARS /PETERSVILLE HERITAGE CONSERVATION STUDY AREA MEETING ON TUESDAY, AUGUST 20, 2013

RECOMMENDATION

That, on the recommendation of the Managing Director, Planning and City Planner, in response to the letter of appeal to the Ontario Municipal Board, dated July 5, 2013 and submitted by Patton Cormier & Associates on behalf of JLC Homes Ltd. relating to By-Law L.S.P. 3471-177 as it relates to 186 Wharncliffe Road North, the Ontario Municipal Board **BE ADVISED** that the Municipal Council has reviewed its decision relating to this matter and sees no reason to alter it, and that the City Solicitor shall represent Council's interests in these matters and may retain outside expert witnesses in support of Council's position.


PURPOSE AND EFFECT OF RECOMMENDED ACTION

The purpose and effect of the recommended action would direct the City Solicitor to represent Council's interest in this matter before the Ontario Municipal Board.

BACKGROUND

Arising from Council meetings on April 30 and May 14, 2013 in response to redevelopment applications in the Blackfriars / Petersville areas, Municipal Council approved By-Law L.S.P. 3431-177 to provide time to study the area for a potential heritage conservation district under Section 40 of the Ontario Heritage Act. The nature of this by-law is to restrict changes to the exteriors of all properties listed in Schedule B of the by-law pending the assessment of the study area by outside consultants to determine if the area meets the Municipal and Provincial criteria to designate the area as a heritage conservation district. By-Law L.S.P. 3431-177 is to be in effect until June 6, 2014.

On July 5, 2013 within the appeal period, a letter was received by Clerks from Patton Cormier & Associates advising that they were issuing notice of appeal to By-Law L.S.P.3431-177 on behalf of JLC Homes (Jon Leahy), owner of the property at the municipal address of 186 Wharncliffe Road.(Appendix 1)



On July12, 2013, Clerks received a letter from P. Lombardi, Siskinds, advising that the firm had been retained by the Blackfriars Residents Group with respect to the heritage conservation study for Blackfriars / Petersville Neighbourhood and would be seeking party status to any OMB hearing, requesting a copy of the appeal and any documentation filed in support of the appeal.(Appendix 2)

In a letter dated July 18, 2013 and received by Clerks on July 22, 2013, the Ontario Municipal Board acknowledged receipt of the appeal by JLC Homes Ltd. (John Leahy) and assigned a case/file number MM130060. At the date of the preparation of this report, no date had been scheduled.

Update on 13 Blackfriars Street

At its meeting on July 23, 2013, members of the Planning and Environment Committee were advised of a property at 13 Blackfriars Street, within the proposed study area for the Blackfriars / Petersville neighbourhood, that had been damaged by fire in 2011. Its owner, B. Storonianski, was denied delegation status at a future Planning and Environment Committee meeting but the committee noted "that staff will work with the applicant to try to resolve this matter." Staff have met with the owner on two occasions and have requested further information with respect to the extent of the damage.






