By-law No. PS-111-_____

A by-law to amend By-law PS-111 entitled, “A by-law to regulate traffic and the parking of motor vehicles in the City of London.”

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act, 2001*, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. **No Parking**

Schedule “2” (No Parking) of the said By-law PS-111 is hereby amended by **deleting** the following rows:

Ashbury Avenue	East & North	A point 55 m south of Surrey Cres (south intersection)	A point 100 m south of the said street	Anytime

Schedule “2” (No Parking) of the said By-law PS-111 is hereby amended by **adding** the following row:

Ashbury Avenue	East & North	A point 28 m south of Surrey Cres (south intersection)	A point 100 m south of the said street	Anytime
Ebury Crescent	North & East	A point 49 m west of Ebury Place	A point 94 m west of the said street	Anytime
Quinton Road	North & East	A point 188 m west of Quinton Place	A point 243 m west of the said street	Anytime
Corley Drive	North & West	Windermere Rd (east intersection)	A point 135 m south of the said street	8:00 am to 6:00 pm

2. **Stop Signs**

Schedule “10” (Entering Highway – Stop Signs on specified streets) of the said By-law PS-111 is hereby amended by **adding** the following rows:

Eastbound	Attawandaron Gate	Attawandaron Road
Northbound	Elderberry Avenue	Skyline Avenue
Northbound	Meadowsweet Trail	Skyline Avenue
Northbound	Sunnystone Road	Skyline Avenue
Southbound	Lindisfarne Road	Skyline Avenue

3. **Yield Signs**

Schedule “11” (Entering Highway – Yield Signs on specified streets) of the said By-law PS-111 is hereby amended by **deleting** the following rows:

Eastbound	Attawandaron Gate	Attawandaron Road
Northbound	Elderberry Avenue	Skyline Avenue
Northbound	Meadowsweet Trail	Skyline Avenue
Northbound	Sunnystone Road	Skyline Avenue
Southbound	Lindisfarne Road	Skyline Avenue

4. This by-law comes into force and effect on the day it is passed.
